Principles of Dutch Procedural Law

- Principle of legality: no penal enforcement power unless based on a Statutory Provision
- Principle of separation of powers and the impartiality of the sitting judiciary
- Principle of equality of arms
- Principle of speedy trial and due process
- Principle of nemo tenetur (there can be no obligation incumbent on the accused) to cooperate via self-incrimination)
- Habeas corpus-principle
- Principle of expediency of the intended penal enforcement action
- Principle that there exists no competence without responsibility

Basics: National

- In the Netherlands the hierarchical relationship government/police is two folded.
- In criminal matters, the police is subordinated to the Crown Prosecutorial Service directed by the Higher Prosecutorial Office in The Hague.
- In matters of public security and national order, the police is subordinated to the Ministry for the Interior.
